I have promoted and participated in the creation of different international projects for IVI, in particular, the creation of a joint venture with NOVA group to develop a network of specialized clinics in India (Nova IVI Fertility) and IVI Middle East, located in Dubai. In February 2017, IVI merged with the American Fertility Group RMA of New Jersey.
